My aim, along with the committee, is to continue and improve the great work Troon started since their arrival here at KGA. Coman Mulry is the Course Superintendent, we look forward to his insights and advice. As always, the course itself has been incredibly busy, possibly one of the busiest 18 hole golf courses in the world, so we must continue with our good agronomic processes and crucially, the essential renovation works. After an extremely wet monsoon season, we are glad to see the golf course come out on the solid side of it. So far, we have received 1256 mm of rain versus 691 mm recorded last year. I must thank all the course personnel for keeping the course in stellar condition. Looking ahead, we aim to work on improving the presentation and conditioning of the golf course. We have identified areas that require additional landscaping which will commence in the coming weeks. The bunkers require an upgrade, we hope to decide in the coming month for the next steps of this planned project. Refurbishment of the tee-off areas is overdue. We will remodel is similar to the tee box upgrades at the 1st and 10th tee. The edges of our lakes will also be a priority moving forward. Finally, we will look to repair the lights on our course, it is not up to the expected quality and requires immediate attention. Governance-Along with the Secretary and the Treasurer, we will look at aligning the workflow and the IT systems. A committee comprising of a few members have been identified, and I look forward to working with them. We must look at professionalising the staff and the out-puts. This is an important initiative and it will take a few years to streamline the same.

#### Chairman - Driving Range

This year will see an upgrade in the club's Driving Range and practice facilities. The bays and artificial turf will be replaced wherever necessary. All the netting around the Range will be repaired or replaced. We will attempt to acquire fresh and better quality Range Balls.In addition, we intend to restart the Junior Golf program for Karnataka youngsters. This is in line with the commitment made by KGA in 1983 when we acquired our land, that our principal aim is to improve Golf in Karnataka. Details of the program will be circulated in due course.
