

Report of the Managing Committee for the year 2024-25

Dear Members,

I am delighted to present the Report of the Managing Committee for the year 2024-2025.

As we reflect on the past year at the Karnataka Golf Association, it is with deep satisfaction and gratitude that I report a year defined by purpose, progress, and participation.

This year saw the successful completion of several key infrastructure projects taken up after the approvals by the esteemed members such as a New Veg Kitchen, the Upper deck bar, course lights and a caddies toilet that directly enhance the member experience. Our phased course lighting project has already illuminated 10 holes, with the remaining 8 to be considered in the future. The buggy track is fully operational making it user friendly for our senior members and those with medical conditions to enjoy the game of golf. Rainwater harvesting systems and vital drainage improvements have been implemented to support our long-term sustainability goals.

Member engagement reached new highs with the KGA Premier League drawing over 624 players across 24 spirited teams, including the KPL Fellowship Round. The KGA Ladies Amateur Open welcomed 125 participants from 30 clubs across the country, setting a new benchmark for the event. Inter-club competitions and junior tournaments also witnessed record turnout and enthusiasm. An International Inter club Tournament was the highlight with KGA playing against The Dubai Creek and Yacht Club, whose rolling trophy was won by KGA.

The Driving Range continues to evolve with new equipment, improved practice bays, and structured training—especially for our junior golfers. The structured training has developed our junior golfers to reach the podium on many occasions in India and abroad.

Landscaping, bunker improvements, and fairway enhancements across the course continue as part of a larger effort to maintain a world-class playing environment.

KGA was allotted 0.71 acres of land by KSTDC, but access to it remains unavailable. Based on member suggestions, we approached our neighbours, M/s. Century Builders, to explore a legal right of way under the Easement Act 1882. Century Builders are open to creating a separate access over the Nala, pending approval from the Government of Karnataka. Discussions are ongoing, and we hope for a resolution soon. We have also proposed that if access is granted, Century Builders may construct the parking area at their cost. In return, KGA would consider allowing them to advertise their project at the site for a fee.

From a financial standpoint, I am pleased to report that all major projects have remained within approved budgets, and the club continues to maintain a healthy surplus. This is a testament to sound planning and oversight by the Managing Committee and management team.

We would like to thank members of the Rules Revision Committee, Mr. Kumar Subramanian - Chairman, Mr. Lukose Vallatharai, IAS, and Shankar S. Poti, for their valuable contributions towards proposing the changes in rules to improve the clarity for administration. The same was presented and approved by the SGM in February 2025. Thanks to our members for approving the rules which have been presented to the government for implementation and are awaiting approval.

Most importantly, I want to acknowledge the extraordinary spirit of our members, special mention to the members of the various sub committees—your participation, feedback, and encouragement have been invaluable in helping KGA thrive as both a competitive arena and a warm community. As we move ahead, I remain confident that our collective commitment to excellence, inclusivity, and innovation will continue to shape KGA's success for years to come.

On behalf of the Committee, I express our deep appreciation to our hardworking staff and vendors, whose commitment to excellence has been pivotal in establishing KGA as a premier golf club. All of this has been possible with the full support of our Members, Managing Committee, and Government Nominees who have continuously provided valuable suggestions and guidance for the club's progressive improvement.

Finance

We are very happy to share that, as envisaged at the beginning of the year, we have been able to steady our operational activities with a focus on optimizing & rationalizing expenditure. We have also kick-started developmental activities to upgrade infrastructure facilities as well as enhance services to our Members.

The key highlights for the financial year 2024-25 is given below:

1. Financial Performance Overview:

- We have clocked operational revenue of Rs 34.33 crores, excluding interest income, primarily on account of enhanced subscription from Members. With interest income, our revenue peaked to Rs 42.79 crores.
- Departmental expenditure was contained at Rs 23.10 crores, through budgetary monitoring & control, yielding savings of 3% over last year.
- Total expenditure, including exceptional items but excluding depreciation and capital expenses, was recorded at Rs 36.84 crores, marginally lower than Rs 37.21 crores incurred last year.
- Overall, we achieved a surplus of Rs 2.27 crores, as compared to a deficit of Rs 5.45 crores last year.

2. Departmental Expenses & Capex:

- Utilization of the Source-Ezy e-procurement platform facilitated procurement transactions worth Rs 3.27 crores, resulting in savings of Rs 52.82 Lakhs through reverse auction and vendor optimization.
- Power, water & fuel expenses, consumed by Course, Driving Range & Clubhouse, was reduced by Rs 18 lakhs.
- The expenditure for conducting the KPL Tournament this year was regulated & restricted to under 70% of the income generated.
- Status of procurement for SGM-approved capital expenditure to bolster course & clubhouse facilities and to maintain service standards and improve operational efficiency is given below:

Golf Course Department:

- · Green Mower: Approved Rs 25.00 Lakhs; Procured Rs 23.55 Lakhs (Savings Rs 0.95 lakhs)
- Fairway Mower: Approved Rs 80.00 Lakhs; PO issued Rs 72.46 Lakhs
- Leaf Picking Machine: Approved Rs 25.00 Lakhs; PO issued Rs 24.80 Lakhs
- Lighting Project: Approved Rs 4.30 Crores; Work Order Issued Rs 2.30 Crores and Rs 8.25 Lakhs to Lighting Consultant

Driving Range Department:

- Yamaha Buggy & Ball Picking Trolley: Approved Rs 13.25 Lakhs; Procured Rs 9.61 Lakhs (Savings: Rs 3.64 Lakhs)
- Range Ball Dispenser: Approved Rs 14.00 Lakhs; Procured Rs 10.78 Lakhs (Savings: Rs 3.22 Lakhs)
- Range Ball Washing Machine: Approved Rs 8.00 Lakhs; PO issued Rs 7.14 Lakhs.
- Weatherproof Cover & Solar Roof Approved Rs 70 Lakhs; WO issued Rs 36.26 Lakhs

Over the years we have been conservative in our capital expenditures. Going forward, keeping in mind the age of our golf course, driving range and clubhouse, we will need to factor in substantial capital investments and / or refurbishments.

4. Investments Management:

Fixed Deposits: During the year Rs 105.05 crores matured and Rs 105.29 crores was re-invested at interest rates ranging from 7.20 % to 7.99 % p.a. keeping in mind the safety of our principal amount & availability to withdraw whenever required. The year end quantum stands at Rs 112.24 crores

• Debt Funds: There was no fresh investment in Debt funds / government bonds. The net asset value of the investment at a cost of Rs 49.70 crores, which was Rs 56.59 crores at year beginning had increased to Rs 61.13 in March 2025, yielding an unrealized gain of Rs 4.54 crores.


5. Statutory & Taxation Updates:

- Refunds order for Rs 2.94 crores (AY 2019-20) and Rs 3.20 crores (AY 2022-23) issued in favour
 of KGA by Hon'ble High Court of Karnataka, application submitted for refund to the Income
 Tax Department.
- Service Tax Appeal pre-deposit of Rs. 7.91 Lakhs done in 2016 ruled in Favor of KGA and refund
 of Pre-Deposit along with Interest Rs. 11.79 Lakhs received during the year.
- Compliance with the 85% spending rule under Income Tax charitable institutions provisions remains a priority, with Rs. 4.38 crore to be spent by 31st March 2026, Rs. 6.92 crore to be spent by 31st March 2028 and Rs. 9.39 crore to be spent by 31st March 2029, as per the return of income filed for AY 2024-25.

6. Other Strategic initiatives:


- Recommendations received from professional legal advisors on potential re-structuring options that could be available to KGA after a comprehensive review of existing financial and operational model is under review by the Tax Advisory Committee & Management Committee in order to achieve operational and tax optimization, keeping in mind future investments in clubhouse & golf course facilities...
- A comprehensive ERP package is under implementation towards commitment for digital transformation of the club under the Digital KGA initiative to integrate accounting, member services, and reporting processes for enhanced efficiency and data accuracy.
- A new KGA member mobile app to enhance member experience & convenience was commissioned supporting online bill payments during the year. We plan to introduce additional features like event ticket booking, etc in the near future.

We would like to thank members and appreciate their foresight in approving initiatives to shore up club resources with enhanced member contributions and approving ambitious projects paving the way for the club to undertake huge strides in infra-structure facilities, operational efficiency and member experience as we move towards our diamond jubilee mark.




Key Financial Highlights

Departmental Receipts (Rs. in Crores)




Total Expenditure (Rs. In Crores)

Golf Course & Irrigation

Cartpath Project Update

We prioritized completing the additional cart path extensions and 5 culverts, a project approved by the SGM last year. The project was taken up by the Project Committee, and after tendering and reviewing specifications, they finalized M/s Pathway Constructions to carry out the work.

We began with cart path side sod removal, soil filling, and leveling due to height variations between the new cart path and existing ground level.

Installation of Bunker Mat on the Bunker

We made the decision to install the bunker mat on the faces and the installation process consisted of: 1) Removing existing sand from the face; 2) Thoroughly washing and drying the bunker; 3) Applying Dendrite adhesive chemical and securing the bunker mat with 6-inch nails; and 4) Adding new bunker sand to a depth of 25mm on the face, compacting, and raking.

The bunker mats will help reduce ball plugging and improve overall bunker maintenance. This will:

- Prevent sand contamination: Bunker mats prevent sand from seeping into the concrete pores, reducing maintenance needs.
- · Reduce water retention: Mats help improve drainage, minimizing water accumulation in the bunkers.
- Enhance playability: Mats provide a consistent and playable surface, allowing golfers to play shots from bunkers with more predictability.

Tee Box Reconstruction:

We are undertaking essential renovations to our golf course tee boxes due to their current small size and increasing player traffic. The existing tee boxes are no longer sufficient, resulting in turf damage, uneven surfaces, slow play, congestion, maintenance challenges, and golfer frustration.

Our architect has designed plans to enlarge all 18 tee boxes. Over the past few years, we have renovated 8 tee boxes, specifically holes 1, 2, 3, 4, 8, 10, 11, and 15. This committee has taken on the most challenging tee box, the 5th hole, where we filled 25 loads of red earth to extend it. We also renovated the 13th tee box, and both were opened last December, receiving positive feedback from members and players.

This month, we started work on two more critical tee boxes, the 6th and 12th holes. We aim to complete these renovations during our term, with a possible reopening in July. Holes 1, 2, 3, 4, 5, 8, 10, 11, 13, and 15 have been completed, and the remaining 8 will form the balance.

Soil Filing and Compaction of Lake Bank

This year, we undertook soil filling and levelling work on the 13th and 7th hole tanks. We have also planted Wedelia plants in these areas.

Enhancing Drainage System Efficiency

To improve the drainage system's efficiency, we have implemented additional measures. We have laid additional drainage pipes in many areas, including the 5th fairway, 18th fairway, and 15th fairway, to reduce water accumulation and facilitate faster drainage. We have identified waterlogging points in these areas during the rains and are addressing them.

Insecticide Citronella Biochemical

We have introduced Citronella Biochemical Insecticide, a non-toxic and environmentally friendly solution to control red ants on trees. This product has a unique mode of action that allows for spraying during play without posing any risk to golfers.

Golf Course Enhancements

We have made several enhancements to the golf course this term. New tee markers featuring the KGA logo have been installed, replacing the old ones. Additionally, we have introduced hazard markers made from recycled plastic in bright red and yellow colours.

Furthermore, we have replaced the "No Trolley" board markers, GUR board markers, sand bin markers, and dustbin markers. We have also repaired and repainted all benches and replaced fairway yardage markers and fairway distance markers. Notably, we have installed yardage plates made of stainless steel (SS) on the sprinklers, which clearly indicate distances to players.

We have undertaken a comprehensive maintenance project to restore our golf course infrastructure. This includes:

- 1. Net Poles and Concrete Beds: restored 84 net poles and concrete beds by:
- Replacing rusted poles to ensure stability and safety.
- Repairing cracks in the concrete beds to prevent further deterioration.
- Repainting the concrete beds with two coats for added protection and durability.
- 2. Net Replacement and Repair: replaced and repaired nets in several areas, including:
- Entire net replacement behind the 1st green.
- Nets at the 2nd, 3rd, and 4th holes have been either replaced or repaired, with replacement done where repair was not feasible.

Roundabout for buggy turning:

We have installed roundabouts for buggy turning areas, particularly near tee boxes and greens, to mitigate grass damage caused by frequent turning. These roundabouts are made of concrete and provide several advantages:

Additional Landscaping

We have added vibrant landscapes throughout our golf course.

- Behind 6th Green: Hydrangea, Lantana (white and purple), and Hamelia Patens creating a beautiful backdrop.
- · 16th Tee Backside: Anthurium plants and lemon grass infusing freshness.
- 9th Tee Right Side: Bright yellow daisies spreading joy.

Machinery Fleet Update

Recent Purchases (MC Approvals)

- 1. Kubota Tractors: We have acquired three Kubota tractors, including two 28 HP and one 50 HP model, equipped with turf tires.
- 2. Greentek Heads: These heads have been instrumental in our recent bi-annual maintenance.

Our SGM has sanctioned the procurement of:

- 1. Toro 5410 Fairway Mower: A heavy-duty mower with hydraulic mowing capabilities, ideal for maintaining our fairways.
- 2. Turftidy 3000: This machine will further enhance our turf maintenance capabilities.
- 3. Dakota Top Dresser: Our new Dakota top dresser arrived last month, which was ordered during the previous SGM project

Cartpath Marking Updates

We have completed the cart path markings, including 66 arrows with stencil words, providing clear guidance to players driving buggies.

Budgeting and Expense control

We are pleased to report that this term we have closely monitored course expenditure by comparing actual spending to the budget monthly. A monthly Management Information System (MIS) review is now a regular Standard Operating Procedure (SOP), enabling effective budgeting and expense control.

Grass nursery updates

We have finally succeeded in setting up a grass nursery at the driving range, near the JDP area.

Bi-Annual Renovation for Golf Course

Our bi-annual renovation program is crucial for maintaining the health and playability of our golf course, which hosts an average of 300+ rounds per day and 110,000 rounds per year. Given the high volume of play, our course requires regular renovation to ensure optimal conditions.

This year, we took a more aggressive approach to achieve optimal results. We conducted -12 mm deeper scarifying, a first in KGA history, to improve soil aeration and reduce soil compaction. Additionally, we used 12 mm tines to vertidrain 8 inches deeper, further enhancing soil structure and drainage. We also employed Procore 17 mm hollow core with 5-inch depth to remove compacted soil and promote healthy root growth. The bi-annual renovation program offers several advantages, including improved soil aeration and drainage, reduced soil compaction, and promoted healthy root growth.

Golf course agronomy practices

Our course agronomy practices are led by a dedicated team of 34 staff members and 22 contract staff through Supreme Care. We prioritize meticulous maintenance, starting our activities early in the morning, typically by 4 am, and even earlier, at 1:30 am, during tournaments.

This year, we have extended our agronomy practices to include all plants and trees, aiming to enhance growth and flowering. By prioritizing agronomy maintenance and adopting a data-driven approach, we ensure our golf course remains in top condition, providing an exceptional experience for players.

Lighting Project Update

We are pleased to share the progress of our lighting project, which was approved in a Special General Meeting (SGM) on September 27, 2024, with a budget of Rs.4.3 crores. The project aims to install new lighting on 9 holes (3, 4, 11, 12, 13, 14, 15, 16, and 17) in phase 1, with a completion target of 12 weeks.

After appointing a consultant on December 12, 2024, to finalize the Bill of Quantities (BOQ), we received quotations from seven vendors and shortlisted four. The estimated project cost, as per the consultant, was Rs.2.68 crores. Following a thorough evaluation, we issued a work order to M/S. C&G Associates, the lowest bidder with a quote of Rs.2.29 crores.

Tournaments, Handicapping & Time Sheet

This year, the Tournament Committee successfully achieved its mandate of:

- 1. Reducing number of tournaments: From 43 to 37
- 2. Lower fees: Tournament fees decreased for members
- 3. Enhanced experience: Improved giveaways and overall tournament experience while staying within the budget

Several steps were also taken towards Operational Improvements;

- 1. Course Fee: Introduced a standardised rate card for tournament course fees
- 2. Sponsorship: Introduced a standardised rate card based on deliverables
- 3. Updated App Info: Published all relevant information such as Annual tournament calendar, Terms of competition, Tournament data etc.

These changes demonstrate the committee's focus on efficiency, cost-effectiveness, and member satisfaction.

As KGA continues to grow its community of active golfers, we recognized the challenges around tee time booking and time sheet management. To address this, we conducted a survey that received valuable feedback from 421 of the approximately 850 active golfers at KGA. The insights gained helped us implement various changes, ensuring that member concerns are heard and addressed—ultimately enhancing the golfing experience at KGA.

Several new initiatives were introduced this year:

Club Champs Development Program (CCDP)

The KGA Club Champs Development Program is a strategic initiative to nurture the club's top amateur golfers by providing them with coaching and facilities to excel in inter-club competitions. By investing in the development of our most talented members, KGA aims to build a strong team that represents the club with distinction, fostering a culture of excellence. We look forward to enhancing this initiative in the future.

KGA Golfer of the Year

The KGA Golfer of the Year award has been revamped to include more tournaments and categories, now featuring Open Men's, Women's, and Seniors divisions. This expansion promotes greater participation and provides broader recognition of golfers' achievements. Standings can be tracked on the app, offering real-time updates and increasing engagement throughout the year.

International Interclub Tournament

We successfully conceptualized and conducted our inaugural International Interclub Tournament with Dubai Creek Golf Club. Despite members being asked to bear their own travel and stay costs, the event drew an overwhelming response with 136 members applying for 30 spots, necessitating a lucky draw to select participants. KGA emerged victorious, winning the rolling trophy. The tournament's success has generated significant interest and confidence among our members, prompting the Managing Committee to explore extending this arrangement to other international affiliated clubs of KGA.

KGA PREMIER LEAGUE (KPL 6)

The KPL Tournament Committee for the 6th edition of KPL successfully fulfilled its mandate to not only enhance the KPL experience significantly but also control costs effectively—reducing expenses from Rs 1.8 crores to Rs 1.3 crores. This led to a substantial increase in profits from Rs 22 lakhs to Rs 74 lakhs. By maintaining a spend ratio below 70% of the Rs 2.1 crores revenue generated, the event adhered to AGM guidelines, allowing excess funds to be used for various other golf development projects.

Based on valuable feedback from members and team owners, this edition of KPL introduced several significant changes aimed at increasing participation, promoting equity across handicap categories, and ensuring a smooth and fair tournament experience. Key changes included:


- Introduction of the Fellowship Round: Enabled all eligible members interested in participating in this marquee tournament to be part of either the main team or the fellowship team across the 24 KPL teams.
- Reform of the Auction & Draft Process: Ensured equitable selection of players across different handicap categories.
- Conflict of Interest Avoidance: Office Bearers and KTC members voluntarily stepped back from participation.

In closing, we would like to thank all our sponsors, the members of Tournament Sub-Committee, Mr Chandrashekar Kini & Mr CS Murali for conducting the golf Clinics, the KPL Tournament Committee, and staff across various functions who contributed to making this a successful tournament year.

Ladies

The Ladies Section had a successful and eventful year, marked by the smooth organisation of the prestigious Ladies Amateur Tournament and three well-attended Medal Rounds. The events reflected a significant elevation in planning and execution standards, with a focus on professionalism, hospitality, and attention to detail.

Participants, including several outstation players, responded warmly to the events, noting the high level of organisation and the welcoming atmosphere. The tournaments served not only as competitive platforms but also as opportunities to build camaraderie and community among women golfers from across the country.



Driving Range, Golf Testing, Caddies & Pro Shop

The past year has been very busy, and the committee has managed to execute all plans laid out at the beginning of the year. There has been an overall effort to enhance and improve the entire golfing experience for our members.

Driving Range Additions and enhancements

Equipment: Ball Picking Buggy and Trolley, Ball washers and Ball Dispensers were procured and added to the range to make the operations more efficient. A transparent process was followed which included Vendor presentations, reference checks and detailed price negotiations. The new equipment will enhance efficiency at the driving range and provide our members with a better Driving Range experience.

All Weather Cover and Solar Panels: A project was undertaken to erect an all-weather cover for Driving Bays to ensure uninterrupted range availability even during heavy rains. This has been a long-standing demand from our esteemed members. Solar panels have also been added to enhance our green thrust.

Nets: There were multiple complaints from our neighbourhood on balls landing in their compound and balconies. Some of the balls made their way to the first fairway as well. We undertook a project to replace the net on both sides of the range with minimum interruption.

Callaway Range Balls: Callaway has given us 8000 additional balls, and this will enable us to replace the balls every alternate month

Caddies Welfare: Caddies are a lifeline for any golf course. The committee was faced with a lot of complaints and suggestions from the caddies at the beginning of the year. Multiple initiatives were taken to cater for their welfare.

Food: There were a lot of complaints from caddies on the food provided. The consensus was to change the current food provider. A new caterer was commissioned, and food was monitored by various subcommittee members for a period of time. Caddies are now happy with the food being provided currently.

SOP for Caddies: A standard SOP was released for caddies to ensure smooth operations and provide guidelines for caddies' daily activities.

Addition of Caddies and skill enhancement: New caddies were added to address the shortage of caddies, and a program was initiated to ensure that they are abreast with new rules and etiquette.

Medical Insurance: Enhanced medical cover of Rs. 4,00,000 was provided to all the caddies.

New Caddy Uniforms: Two sets of new uniforms were provided for caddies. The same was provided by DNA group.

Coaching:

The contracts for coaches were renewed as required.

Junior Golf Development Program

The JDP at KGA was established three years ago with an aim to support and nurture young budding golfers. The program has a comprehensive coaching framework run by Head coach, Rahul Ganapathy, thereby fulfilling KGAs primary objectives of developing the game of golf.

The program strength is about 32 golfers and 18 CSR golfers and summer camp 27 golfers have registered.

A corpus of Rs 5 Crore was sanctioned by SGM and interest accrued from this amount is earmarked to fund JDP out of which 25% is earmarked for CSR program mainly focussing on employees' children. An additional corpus of Rs 5 Crore (totalling Rs 10 Crore) was sanctioned by SGM this year and interest accrued on this amount is earmarked for JDP program. This year, 12 junior golfers who train at our academy have been given financial support as part of the JDP program, based on approved SOP.

Under the CSR initiative, we have sponsored young talented golfers, mostly children of Caddies, to participate in many south zone junior golf tournaments.

During the year, KGA contributed Rs. 42.66 lakhs towards the Junior Golf Development Program. This reflects KGA's commitment to inclusivity and nurturing talent at the grassroots level. This year we started a JDP tournament, which we plan to conduct as a monthly medal.



Clubhouse

Our committee's goal was to "Provide Service Excellence through Cost Saving". Here is a summary of our achievements:

Cost Savings Initiatives

After the formation of the Sub Committee our First Assignment began with study and review of the Actual Spend and Budgeted Spend, projections received from the Finance department around the end of July 2024. Received data was then analysed and observations were recorded. Our recommendations were as follows:

- 1. **Security Service:** Suggested Change of the service provider, resulting in cost saving of Rs. 1 Lakh per month, and introduced a proper tendering process.
- 2. **Housekeeping:** Appointed a new vendor through proper tendering process, saving over Rs. 2 Lakhs per month.

Infrastructure Upgrades

- 1. Caddies and Staff Facilities: Proposed rebuilding of Toilet/Restroom facilities for better hygiene and working conditions.
- 2. **New Veg. Kitchen:** Proposed a modern, visible kitchen with seating and service area, improving hygiene and members' experience. Presently the basement kitchen has questionable hygienic conditions.
- 3. Upper Deck Bar: Earlier the Umbrella bar area was in dilapidated state hence we proposed an athletic semi-alfresco lounge bar with roof and smoking area, providing members with a relaxed post-golf experience.

Project Execution

- 1. **Design and Budget Approval:** Obtained SGM approval for designs and budgets, ensuring cost-effectiveness.
- 2. Appointment of Architect: Floated tenders, interviewed firms, and appointed a suitable architect for the projects.
- 3. **Project Completion:** By appointing contractors through a rigorous process, continuous monitoring and successful completion of projects, staying within budget, and ensuring substantial savings for the club.

Other Initiatives

- 1. **Gym Equipment Upgrade:** Upgraded gym equipment to improve member satisfaction and operational efficiency.
- 2. Maintenance and Upkeep: Prioritized maintenance of the Clubhouse, support facilities, swimming pool, and surroundings.

Through these initiatives, we have achieved significant cost savings and improved member experience. Our sub committee's efforts have set a base foundation for the club's future operations.

Food & Beverage

This year's F&B sub-committee team was a good mix of experienced members and hospitality professionals. Our F&B advisor Mr Sanjeev Sharma (Former General Manager of Taj) & Mr Koshy- F&B Manager, both were consistently involved to manage the F&B initiatives.

The Food & Beverage Team remains committed to delivering member-friendly dining experiences while staying ahead of evolving bar and culinary trends. The focus of this year's F&B committee was to introduce new trends and enhance the overall services.

The F&B infrastructure needed to be upgraded, hence the KGA management decided to build a new kitchen for vegetarian south-Indian cuisine with additional seating capacity in the food court area. The Double Eagle Bar is a favourite with members, and the long pending project of a trendy new Umbrella Bar was taken up this year.

In line with our planned strategy, we have implemented the following key initiatives:

- 1. Planned Events, Curated Menus & Interactive Culinary Experiences: This year we have done around a dozen Food Promotions based on International & Regional themes. Special themes & interactive cooking stations were introduced during weekends. The menus are curated to match the themes of events.
- 2. F&B arrangements for Golf Tournaments: Designing F&B offerings for golf tournaments and events, this includes lunch & cocktail dinner arrangements. The KPL was one of the biggest & most prestigious events we worked on. Every year the F & B department sets new benchmarks in terms of creative menus, buffet set-up and bar counters.
- 3. F&B facility upgrades- New Kitchen & Dining space: We have approved plans for and begun the execution of the enhancement of existing facilities to improve operational efficiency and guest comfort. Soon we will have a fully equipped new vegetarian show-kitchen and expanded dining capacity in the food court area with additional seating in a relaxed and upscale setting.
- 4. **New Trendy Bar:** Introducing a contemporary bar concept featuring craft cocktails, premium spirits, and a chic ambience.
- 5. **Digital Integration:** Implementing QR code-based menus and effective feedback systems to streamline the service issues.
- 6. Initiatives towards hygiene. Food safety & operational processes: regular audits are done to check the upkeep of kitchens and frequent reviews to improve the F&B operations. We are conducting the microbiological tests of food, hand swab tests & water quality checks every month through an outside agency, and the results are reviewed for improvements and staff training,

Events & Ceremonies

The journey of the last one year has been challenging, fulfilling, and a great learning experience for all of us in the Events & Ceremonies sub-committee.

Members of KGA gave us an unprecedented and overwhelming response to all our events. It is a matter of pride that participation in this year's Kannada Rajyotsava celebrations at KGA exceeded all past celebrations by over 300%. The musical event featuring the very popular singer Guru Kiran saw the participation of 750 members and their guests.

Another record-breaking event by a significant margin was our Diwali event. Managing such an event wouldn't have been possible without the support of the President, all members of the Managing Committee, the subcommittee, and the KGA Staff. Similarly our New Year's Eve involved extensive planning towards meticulous execution. Special thanks are due to the local police and our ground staff.

While all our events did exceedingly well, the following events merit special mention. Each of these events was curated with their own theme, separate positioning and packaging, designed to entertain separate segments of members.

As a conscious effort, we made our entertainment platform available to KGA members and their families who performed on our stage. Our Tambola team has made many changes in the way Tambola is conducted in KGA. We are grateful for all the inter-departmental collaboration and support received to make all our events a success.

Information Technology

A pathbreaking achievement by the committee this year was the crafting and implementation of a co-ownership model with the vendor for the KGA ERP project. This model not only saved us a substantial upfront investment of nearly Rs. 3 crores but also created a potential future revenue stream for KGA, as Canarys Automation plans to deploy this solution at other golf courses globally. By adopting this model, KGA will pay only Rs. 60 lakhs in 1st year and Rs. 57.5 Lakhs per annum for the next 4 years (all inclusive) + GST, compared to the earlier upfront investment nearly Rs. 3 crores and an additional Rs. 50 lakhs per annum towards maintenance and license fees. Moreover, 80% of the cost is expected to be recovered by transitioning to the new platform and sunsetting existing solutions.

Project DigiGolf: A New Era Begins

As part of KGA's commitment to innovation and operational excellence, we are excited to share progress on our digital transformation journey — the development of an ERP platform in collaboration with Canarys Automation. This platform is set to redefine how the club operates, engages, and grows.

April 1st: Beta Go-Live of Microsoft Business Central

We successfully went beta live on April 1st with Microsoft Business Central, marking a major milestone in automating and streamlining two of our most critical back-office functions:

- Accounting & Finance: Real-time tracking of financial data, improved accuracy, and robust reporting to support decision-making at all levels.
- Procurement & Material Management: Seamless vendor management, purchase workflows, and inventory control ensuring the right materials are available at the right time.

This rollout lays the foundation for data-driven efficiency across departments and replaces multiple legacy systems with a unified solution.

What's Next? A Comprehensive Digital Ecosystem

The implementation journey is gaining momentum. Here's what's currently underway:

POS (Point of Sale) System - Imagine faster checkouts across all touchpoints — pro shop, reception, bar, and restaurant. Our new POS system will be fully integrated with inventory and member accounts, enabling real-time billing, stock updates, and member-specific pricing or benefits.

Applicant Journey to Membership - Adigital-first journey from "Applicant to Member" is in development. New applicants will soon enjoy a smooth, transparent, and guided experience — from application submission to document verification, interviews, and final approvals.

HRMS (Human Resource Management System) - Our people are at the heart of everything we do. The upcoming HRMS will empower HR and management with tools for:

- · Staff onboarding and record management
- · Leave and attendance tracking
- Appraisals, training, and performance management

New Golf Course Committee

Since the last AGM, the New Golf Course Committee (NGCC) has made significant progress towards procuring the second Golf Course.

As a first step, the NGCC made a breakthrough with Zion Hills Golf County to enable our Golfers to play at Zion Hills for a nominal fee which was borne by KGA. The response has been phenomenal. Apart from playing at Zion Hills, additional concessions on F&B and discounts on Villa rentals to our members have been agreed upon. Zion Hills has also graciously agreed to let our Junior Golfers have unlimited access to their Golf Course.

The above has been documented by way of an Agreement with Zion Hills Golf County.

Further, we are exploring two options for procuring a Golf Course ourselves.

- The NGCC along with the President and Hon. Secretary visited Hesaraghatta and then approached the Secretary, Tourism and Managing Director, KSTDC for sanction of 140 acres of land to KGA, which at present is in the possession of the Film Development Corporation and unused for about 40 years. We are following up with the Government for allotment of the said land.
- 2. The NGCC has also explored various other options, including the lease of land at many places with various Land Owners of land banks.

The NGCC is also in discussion with the Builder who has offered 130 acres of his property to KGA, wherein he will build the Golf Course and the Club House, and the KGA would operate and maintain the same. The understanding is, KGA will have exclusive rights on the Golf Course and the Club House, including membership and will be on a revenue sharing model. The discussions are still in the initial stages and once the details are fine-tuned it will be placed before the members for their consideration.

New Clubhouse Committee

The New Clubhouse Subcommittee was reconstituted with Mr. Dinesh Reddy as the Chairman, with the following as members.

- 1. Dr. Amar Kumar Pandey, IPS
- 2. Mr. Sivasailam N, IAS
- 3. Mr. M.S. Siddaraj,
- 4. Mr. Swaroop Anish

It was decided to consider taking up the renovation and modification for which the permission was given by the Managing Director, Karnataka State Tourism Development Corporation vide their letter No: KSTDC/MD/KGA/01/18-19/2024-25 dated 19.04.2024.

However, the subcommittee felt that once any major renovation is taken up, it shall meet the demands of the growing membership for at least the next 20-25 years. They are also of the view that it should be a financially viable proposition.

Further, the present office, situated in the basement, invariably gets flooded during heavy monsoons destroying important documents.

All these issues had to be addressed without changing the existing footprint.

To consolidate these issues, it was necessary to appoint a suitable firm of Architects. To this effect, a tender process was initiated and the firm of Architects was selected to put in place various aspects of the project.

The New Building above the swimming pool will have enough space for F&B activities, well-equipped party halls, 40 guest rooms of international standards, rooftop well landscaped dining duly covered by solar panels, which will generate adequate power for the whole complex.

Likewise, in the main clubhouse the existing lower deck will be elevated, and the entire area will be on one level.

The present mezzanine floor will be extended to provide the view of the Golf Course and will be used as a Fine Dine Area.

The Second Floor will accommodate the office, which will be shifted from the present basement. The Roof Top will be beautifully landscaped, which can also be used for parties and Dining.

The detailed proposal is submitted to the Managing Director, Karnataka State Tourism Development Corporation, and once it is approved, it is proposed to convene an open house and take it to the General Body for its consideration and approval.



Independent Auditor's Report to the Members of Karnataka Golf Association

Report on the Audit of Financial Statements

Qualified Opinion

We have audited the financial statements of Karnataka Golf Association ("the Association"), which comprise the Balance Sheet as at 31 March, 2025 and the Income and Expenditure Account for the year ended, and notes to the financial statement including a summary of the significant accounting policies and other explanatory Information.

In our opinion and to the best of our information and according to the explanations given to us, except for the possible effects of the matters described in the Basis for Qualified Opinion paragraph, the aforesaid financial statements give a true and fair view in conformity with the accounting principles generally accepted in India of state of affairs of the Association as at 31st March 2025 and surplus for the year ended on that date.

Basis for Qualified Opinion

We conducted our audit in accordance with the Standards on Auditing (SAs) issued by The Institute of Chartered Accountants of India. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statement section of our report. We are independent of the Association in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for qualified opinion.

1. As mentioned in Note 3.5 (A) of Schedule 14, Confirmation of balances of Advances to Suppliers, amounts receivable from Others, Sundry Creditors, Debit card/Guest card balances, Retention amounts payable to Service Providers and Other Liabilities are awaited, although the association has sent appropriate communication seeking confirmation of balances from all parties. In the absence of confirmations from the said parties the balance shown in the books of Association has been considered.

2. As mentioned in Note 3.5 (B) of Schedule 14, the reconciliation of dues from / to members is pending as on date of this report.

Information other than the financial statements and auditors' report thereon

The Managing Committee (Management) is responsible for other information. The other information comprises of Report of the Managing Committee and Key Financial Highlights but does not include the financial statements and our auditor's report thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information identified above when it becomes available and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit, or otherwise appears to be materially misstated.

The Report of the Managing Committee and Key Financial Highlights is expected to be made available to us after the date of this auditor's report.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

Responsibilities of Management for the Financial Statements.

Notes to and forming part of the financial statements for the year ended 31st March 2025.

1. Background

The Karnataka Golf Association is a society registered on 03.09.1973 under the Mysore Societies Registration Act 1960 and now governed under The Karnataka Societies Registration Act, 1960. The objects of the society is to achieve the health and physical fitness of the people through promotion of sports particularly the game of golf and to control, regulate, help, encourage and promote the game of golf in the area under the jurisdiction of the society and create, foster and maintain friendly relationship among golfers, select individuals to represent the Association in tournaments, to arrange, execute and facilitate visit of golf teams and to maintain a golf course in Bangalore open to the members of the Association.

2. Significant Accounting Policies

2.1 Basis of preparation of financial statements

The financial statements are prepared in accordance with Indian Generally Accepted Accounting Principles (Indian GAAP) under the historical cost convention on accrual basis. IGAAP comprises mandatory Accounting Standards as notified by the Institute of Chartered Accountants of India and adopted to the extent applicable to the Association.

2.2 Use of estimates

The preparation of financial statements in conformity with GAAP requires the management to make estimates and assumptions that affect the reported balances of assets and liabilities and disclosures of contingent liabilities at the date of the financial statements and reported amounts of income and expenses during the year.

Although these estimates are based upon management's best knowledge of current events and actions, actual results could differ from these estimates. The difference, if any, between the actual results and estimates are recognized in the period in which the results are known / materialize.

2.3 Inventories

Inventories are valued at the lower of Cost and Net Realizable Value. The valuation on cost basis has been made by adopting both the weighted average method in case of certain inventory and FIFO method in other cases comprised in the inventory.

The Inventory pertaining to Merchandise and other items connected with Golden Jubilee Celebrations are valued at cost as certified by the management.

2.4 Property, Plant and Equipment

Property, plant and equipment are tangible items that:

a. are held for use in the production or supply of goods or services, for rental to others, or for administrative purposes; and

b. are expected to be used during more than a period of twelve months.

The Club follows Cost Model as its Accounting Policy for all Classes of Property, plant and equipment. The Assets are stated at cost net of tax/duty credit availed, if any, less accumulated depreciation and impairment losses, if any,

Costs include all expenses incurred to bring the assets to its present location and condition. All direct costs incurred till the date on which the fixed assets are ready for use are capitalized.

2.5 Depreciation and amortization.

Property, Plant & Equipment are depreciated on Straight Line method as per the rates specified below

Depreciation for assets purchased / sold during a year is charged on pro-rata basis.

2.6 Capital Work in Progress:

The Expenditure incurred on Assets during the course of construction/development are disclosed under capital work in progress account (CWIP) and transferred to the appropriate category of Property, Plant and Equipment at the point when the said asset is complete and ready to put to use.

2.7 Revenue Recognition

Annual & Monthly subscription fee from members are recognized as income on accrual basis. Revenue from outlets and outsourced facilities are recognized as per the terms of the contract with the service providers.

Interest on Fixed Deposits with Banks are recognized on accrual basis.

Sponsorship and other income are accounted for the respective departments for which it has been received.

The subscription charges has increased w.e.f 01/04/2024 pursuant to the resolution passed at Special General Meeting (SGM) of Members held on 20.10.2023. Further, it has been resolved, in the Third Managing Committee meeting held on 13/08/2024, that a sum of Rs.150/- from the monthly general subscription charges of Rs.600/- received from members has been transferred from Club House Department to General Department to defray common expenditures.

2.8 Investments

Long term Investments are carried individually at cost less provision for permanent diminution in the value of such investments.

The cost of investments includes acquisition charges such as brokerage, fees and duties.

2.9 Employee Benefits

i) Short Term Employee Benefits

All employee benefits falling due wholly within 12 months of rendering the service are classified as short-term employee benefits. The benefits like salaries, wages, short term compensated absences, etc. and the expected cost of bonus, ex-gratia and performance incentives, are charged to Income & Expenditure Account of the year in which the employee renders the related service.

ii) Post-employment benefits and Other Long-Term Employee benefits

(a) Defined Contribution Plans

These are plans in which the entity pays pre-defined amounts to separate funds. These comprise of contribution to the Employees Provident Fund, ESI and the like. The entity's payments to the Defined contribution plans are charged to the Income & Expenditure Account of the year when the employees render the related service that the payment covers.

(b) Defined Benefit Plans

Gratuity Liability and other long-term benefits for eligible employees are defined benefit obligation and are provided based on an actuarial valuation on projected unit credit method made at the end of financial period according to actuarial valuation.

Obligation is measured at the present value of estimated future cash flows using discounted rate that is determined by reference to market yields at the Balance Sheet date on Government Securities where the currency and terms of the Government Securities are consistent with the currency and estimated terms of the defined benefit obligation.

Actuarial gains and losses comprise experience adjustments and the effects of changes in actuarial assumptions are recognized immediately in the Income & Expenditure Account and are not deferred.

2.10 Impairment of Assets:

At the end of each year, the Association determines whether a provision should be made for impairment loss on Assets by considering the indications that an impairment loss may have occurred in accordance with AS-28 "Impairment of Assets", where the recoverable amount of any fixed asset is lower than its carrying amount, a provision for impairment loss on Assets is made for the difference.

2.11 Intangible Assets:

Intangible assets are stated at cost of acquisition net of recoverable taxes.

2.12 Provisions / Contingent Liabilities:

A provision is recognized if, as a result of a past event, the Association has a present legal obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation. Provisions are determined by the best estimate of the outflow of economic benefits required to settle the obligation at the reporting date.

Where no reliable estimate can be made, a disclosure is made as contingent liability. A disclosure for a contingent liability is also made when there is a possible obligation or a present obligation that may, but probably will not, require an outflow of resources. However, where there is a possible obligation or a present obligation in respect of which the likelihood of outflow of resources is remote, no provision or disclosure is made.

2.13 Allocation of Income & expenses to various Departments

The income & expenditure to the various departments have been apportioned and accounted based on the revenues generated by the respective department and expenditure directly attributable to the said department. The Income from the various departments have been segregated and the revenue earned from cover charges, overdue charges, interest on deposits, profit on sale of debt funds are classified under General Income. The common expenditure which cannot be identified as incurred towards a specific department have been classified and treated as general expenditure.

2.14 Fees for admission to membership:

The amounts received from persons towards Admission Fee to membership are capitalized and transferred to Admission Fee under the head Capital Fund on grant of membership to the Applicant.

The advance received for membership till the grant of membership is disclosed under the head "Fees for admission to membership received in advance".

2.15. Foreign Currency Transactions

Transactions in foreign currency are accounted for at the exchange rates prevailing at the time of transaction. However, in case of transactions taking place through bank accounts maintained in foreign currency, the same are recorded at notional rates. Balances in such foreign currency accounts at the year-end are converted at the prevailing exchange rates. Current assets and liabilities at the year-end are restated at the prevailing exchange rates and the difference between the year end and the actual/notional rates is recognized as income or expense in the Accounts.

3.2 Income Tax

a. The Association is recognized as a charitable institution and has been granted registration under Section 12AB of the Income Tax Act, 1961 with effect from 01.04.2021 and is valid for a period of 5 years. The Association desires to retain the status as Charitable Institution as per the provisions of the Income Tax Act, 1961. The Association is consequently claiming exemption of the income earned by it as per the provisions of Section 11 and 12 of the Income Tax Act, 1961. The income of the Association is mainly derived from the activities related to the advancement of the game of golf and all other activities, such as health Club/wellness Centre, swimming etc., which are all substantially connected to the main objects. The Association is constantly engaging with tax experts and seeking their advice and opinion on the measures to be taken to ensure that the Association retains its status as a charitable institution under the provisions of the Income Tax Act, 1961.

b. The Association has not made any provision towards income tax for the year as the Association is claiming exemption of its income as a charitable institution duly registered under Section 12 AB of the Income Tax Act and will be filing the requisite forms prescribed both for claiming such exemption and towards the shortfall, if any, in the application funds as against that required to be applied as stipulated under the Income Tax Act.

3.3 Contingent Liability

Income Tax

The Income Tax Department has raised certain demands as detailed hereunder arising out of the treatment of certain receipts, expenditure and allowance claimed by the Association, which have been disputed by the Association in the appropriate judicial forums.

The Association had filed a Writ Petition before the Hon'ble High Court of Karnataka. The said Writ Petition has been held in the favour of the Association. It is to be noted that once the said refund for AY 2019-20 and AY 2022-23 is processed by the Income Tax Department without adjusting against the tax demand mentioned above will increase by the said refund of Rs. 6,62,08,713/(refund amount along with interest).

ii) Legal Disputes:

a. There are certain disputes with few parties with regard to car parking area and the same is pending before the appropriate legal forum.

b. Exide Life Insurance Company Limited was granted corporate membership of the Association with effect from 01/04/2019 for a period of 15 Years. The company subsequently merged with HDFC Life Insurance Company Limited HDFC Life Insurance Company Limited submitted a letter for transfer of membership from Exide Life Insurance Company Limited to HDFC Life Insurance Company Limited. The Association has terminated the membership of Exide Life Insurance Company Limited as there is no provision for membership transfer as per the Memorandum and Rules of the Association.

M/s HDFC Life Insurance Company Limited filed a suit with Hon'ble 4th Additional District Consumer Disputes Redressal Commission and Hon'ble 4th Additional District Consumer Disputes Redressal Commission passed an order on 28.02.2025 directing the Association to refund the amount of Rs 35,40,000/- along with interest of 6% and compensation of 20,000/- for deficiency of service and Rs 10,000/- towards the cost of proceedings. The Association has filed first Appeal (404/2025) before the Hon'ble Consumer Disputes Redressal State Commission against the order passed by the Hon'ble 4th Additional District Consumer Disputes Redressal Commission in appeal no 404/2025. The Association has paid the deposit of Rs. 24,22,200/-, being 50% of the amount ordered by the Hon'ble 4th Additional District Consumer Disputes Redressal Commission. The Hon'ble Consumer Disputes Redressal State Commission has granted the stay for balance till the date of next hearing.

c. The Bangalore Water Supply & Sewerage Board (BWSSB) levied an amount of Rs. 25,44,139/as previous outstanding dues in the month of June 2024. The Association had filed the letter to BWSSB on 19.08.2024 stating that the Association is regular in making the payment pertaining to water charges on monthly basis and there are no previous dues. Further, in the said letter it has also been mentioned that the same error also occurred in the bill dated 08.02.2021 and after the due representation from the Association the same has been reversed.

The liability of the outcome of the above disputes is not ascertainable as on the date of this report.

- 3.4 The Association has entered into a Lease Agreement with KSTDC on 19th May 2018 for 124 acres of Land at Challaghatta Tank Bed, Bengaluru for a period of 30 years commencing from 17th May 2010. In terms of the said lease agreement the land lease rent payable per annum is 2% on the Gross Annual Income including Departmental Receipts, Interest income from Bank and Membership Fee capitalized during the year. During the year an amount of Rs. 1,16,00,681/has been charged to the Income and Expenditure Account as Land Lease rent based on the computation of Gross Annual Receipts.
- 3.5 A. Confirmation of balances of Advances to Suppliers, amounts receivable from Others, Sundry Creditors, Debit card/Guest card balances, Retention amounts payable to Service Providers and Other Liabilities are awaited, although the Association has sent appropriate communication seeking confirmation of balances from all parties. In the absence of confirmations from the said parties the balance shown in the books of the Association has been considered. The consequential effect due to the above will be accounted on receipt of confirmation and reconciliation of balances.
- B. The Association has shown Rs. 1,32,08,621/- as receivable from members in its books of accounts which have been disclosed in the financial statements under Schedule No. 11 "Receivables" and the same has not been reconciled with due from members as per Clubman software. The Association is in the process of reconciling the dues from/to members between Clubman Software and books of accounts maintained in tally which is yet to be completed as on date. The consequential effect of reconciliation will be given as and when reconciled.

3.6 Disclosure With Regard to Micro Enterprises and Small Scale Undertaking:

In view of insufficient information received from suppliers concerning their status as "Micro Enterprise", "Small Enterprise" as defined under clause (h) & (m) of Section 2 of the Micro, Small and Medium Enterprises Development Act, 2006, disclosure of particulars regarding unpaid amounts to such suppliers could not be made in the accounts.

^{*} The Income Tax refund pertaining to AY 2019-20 and AY 2022-23 amounting to Rs. 3,24,37,583/and Rs. 3,37,71,130/- respectively has been adjusted against the outstanding demand of AY 2010-11 and AY 2013-14, AY 2014-15 and AY 2017-18. The tax demand mentioned above is after adjusting the refund for AY 2019-20 and AY 2022-23.

In view of insufficient information received from suppliers concerning their status as Small Scale undertaking as defined under clause (j) of section 3 of the Industries (Development & Regulations) Act 1951, disclosure of particulars regarding unpaid amounts to such suppliers has been made not been made in the books of accounts for the year ended 31.3.25.

3.7 Tee Box Renovation

The Association has incurred an expense of Rs. 29,86,562/- towards the Tee box Renovation which is the work executed to stabilize the soil, make the ground even and enable firm footing. The expenditure incurred is primarily to maintain, improve the durability and playability of the tee areas in golf course and it does not by itself result in creation of an asset independently. Consequently, the said expenses have been treated as period cost and debited to the Income and Expenditure Account for the current year.

- 3.8 In pursuance of the resolution passed at the Special General meeting of the Members held on 18/04/2022, the Interest earned on Rupees Five Crores (Rs.5 Crores) is to be earmarked under the nomenclature KGA Foundation Fund to be utilized to nurture budding talents in the game of Golf. Further, it has been resolved in the Special General Meeting of the Members held on 05/02/2025 to increase the said amount from Rs. 5 crores to Rs. 10 crores. The Interest earned and amount spent out of the same has been disclosed separately in the financial statements as Note No.3.
- 3.9 The Association had entered into an agreement with M/s Canarys Automations Limited for implementation and maintenance of ERP. As per the said agreement the Implementation fee/charges is Rs 60 Lakhs, out of the same Rs 30 Lakhs has been paid till year end. Further, the all-inclusive maintenance fees payable for next four years is Rs. 57.5 lakhs per annum excluding GST.
- **3.10** Previous year's figures have been reclassified and regrouped wherever necessary, so as to make them comparable with the figures of the current year.

The Hon. ELECTION OF MANAGING COMMITTEE

ELECTION RULES

20.2 Eligibility

20.2.1 A candidate seeking election should be a member for a period of 5 continuous years with a handicap in this Association for the preceding 12 months continuously.

20.2.2 The candidate for the office of President, Captain, Hon. Secretary and Hon. Treasurer should have been an elected Member of the Committee for a minimum period of one Annual year.

20.2.3 Members who have been elected to the Committee for three consecutive years shall be eligible for re-election for any position only after a break of one year excepting for election for the post of President.

20.3 Nominations

20.3.1 A candidate for election shall be proposed by a member eligible to vote and seconded by two other such members.

20.3.2 An eligible member can propose or second only one candidate irrespective of the positions in the Committee.

20.4 Electoral Committee:

20.4.1 The Managing Committee shall appoint a Chief Electoral Officer who is a member for minimum period of 20 years, shall constitute an Electoral Committee of which he/she shall be the Chairman and two other Senior Members (minimum 20 years & above membership of the Association.)

20.4.2 Their role shall include:

- 1. Scrutiny of candidates. The decisions of the Electoral Committee shall be final and binding and in the event of rejection of any candidate(s) they will record the reasons in writing. The names of the rejected candidate(s) shall not be included in the final list of candidates.
- 2. Conduct the election process
- 3. Appoint tellers
- 4. Announcement of results.

20.4.3 The decision of the Electoral Committee shall be final and binding.

20.4.4 Once the Calendar of Event is announced, all communications relating to election process shall be though the Chief Electoral Officer.

20.4.5 Electoral Committee will continue to support the tellers throughout the elections and enforce standard protocol until the completion of election process.

20.5 Withdrawal

20.5.1 Any candidate wishing to withdraw from the election shall do so in writing to the Honorary Secretary on or before the date set for withdrawal

20.6 Final List of Candidates

20.6.1 The final list of candidates for election to the Committee along with the names of the proposer and seconders and a brief bio-data including information of disciplinary action, if any of the Candidate, shall be published on the Notice Board at least 10 days before the date of the meeting.

20.6.2 Simultaneously this list shall also be sent to every member in India by Post/Courier/Email.

20.6.3 A candidate contesting the election shall not canvas directly or indirectly through Letters/ Notices/Advertisements/e-mail/ SMS or through any other form of communication. Breach of this rule by the candidate or any other Member/Associate of the Association will invite disciplinary action in terms of Rule 26 (Conduct of Members)

20.6.4 Candidates appearing on the final list shall be called for a meeting on the date and time fixed by the Managing Committee to meet with voting members formally prior to the elections, to introduce themselves and present their vision. Such meeting shall be chaired by the Chief Electoral Officer.

20.7 Tellers

The balloting shall be conducted by Tellers approved by Members at the General Meeting.

20.8 Balloting

20.8.1 At the General Meeting, lists showing the names of the candidates for the Office Bearers and Committee Members, shall be issued to each Member eligible to vote.

20.8.2 Every Member shall vote to elect the President, Captain, Hon. Secretary, Hon. Treasurer and six Members for the Managing Committee. Any ballot which does not conform to this requirement shall be invalid.

20.8.3 In case of a tie the winner/s shall be determined by seniority of Membership and in case of equal seniority by a draw of lots.

20.8.4 The voting may be conducted either by using paper ballots or Electronic Machines.


20.9 Tenure
